## **Rule 803 Exceptions to the Rule Against Hearsay Federal**

December 9th, 2018 - Rule 803 defines when hearsay statements are admissible in evidence even though the declarant is available as a witness. The Senate amendments make three changes in this rule. The House bill provides in subsection 6 that records of a regularly conducted "business" activity qualify for admission into evidence as an exception to the hearsay rule.
